Discuss and consider possible action, including approval, approval with conditions, or denial of a request by Allison Family, L.C.C., Developer; JR Donelson, Engineer/Surveyor; for Final Plat approval of Ashleigh Park Phase I, a subdivision of approximately 8.6 acres with 24 lots bounded on the south by a boundary described by metes and bounds, and on the north by East 146th Street South. Ashleigh Park Phase I will be located on Block 1, and 2, and 3, that abut East 146th Street South, and on Blocks 4, 5, and 6 that abut East 147th Street South. This tract is located in Section 13 Township 17 North Range 15 East of the Indian Base and Meridian, Wagoner County, State of Oklahoma.
