2. Award of Bid

Community Development Director Mark Seibold discussed bids received for the Phase I Improvements at Roland Park. Magnum Construction, Inc. was the low bidder.

3. Ordinance 850 – Capital Improvements Tax

Roger Kolman discussed the need for a new ordinance related to the proposed 1% sales tax to fund capital improvements. A new election will be held on February 8, 2022, with the tax to begin July 1, 2022 if the sales tax increase is approved.

Motion by Harold Chance, second by Randy Woodward, to adopt Ordinance 850, an ordinance of the City of Coweta, Oklahoma that: (A) levies and assesses a One Percent (1%) sales tax on the gross receipts of proceeds on taxable sales of goods and services, as defined in the ordinance, in the City of Coweta, Oklahoma in addition to all present sales taxes upon such gross receipts or proceeds for the purpose of funding capital improvements pertaining to road and street improvements, water and wastewater system improvements, storm sewer improvements, acquisition of parks maintenance equipment, improvements to public parks lands and facilities, improvements to public safety facilities, and acquisition of public safety vehicles and equipment, all within the said city of Coweta, Oklahoma and/or to be applied or pledged toward the payment of principal and interest on any indebtedness, including refunding indebtedness, incurred by or on behalf of the City of Coweta, Oklahoma for such purposes; (B) provides for such sales tax to begin July 1, 2022; (C) provides for the duration of such sales tax to be permanent; (D) prescribes procedures for the collection and remittance of such sales tax and penalties for the failure to do so; and (E) includes such other provisions, terms and conditions as necessary and lawful for the effective implementation and enforcement of this ordinance.

4. Resolution 2021-31 Special Election

5. Ordinance 852 – Fireworks

Roger Kolman presented a proposed amendment to the Coweta City Code of Ordinances to allow for the sale of fireworks between July 3 and 4, and December 15 to December 31.

Discussion was held regarding the sale dates and dates allowed for discharging fireworks. The proposed Ordinance 852 was revised to allow the discharge of fireworks on December 31 between the hours of 10:00 AM to 12:00 midnight, and January 1 between the hours of 12:00 AM and 10:00 PM each year. This is in addition to the existing dates of July 3 and July 4 between 10:00 AM and midnight.

Motion by Randy Woodward, second by Harold Chance, to adopt Ordinance 852, an ordinance of the City of Coweta, Oklahoma relating to Part 10, Offenses, Chapter 3 Offenses against peace, of the Code of Ordinances of the City of Coweta, Oklahoma, specifically repealing all existing provisions of Part 10, Chapter 3, Section 10-303 Fireworks Restricted, adopting new provisions pertaining to Fireworks Restricted, providing for repeal, providing for severability, and declaring an emergency.

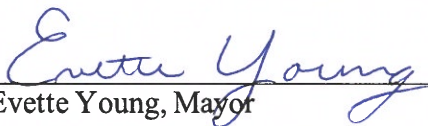
